Minutes and conclusions

Opening/Welcome

The meeting was opened by GLAFKA's team members Gabriela Vlčková and Lukáš Novotný. Partners were welcomed at . There were provided organizational information to participant as well they were informed about the meeting schedule and programme.

Intellectual output

Based on the previous discussions and conclusion done during previous partners meetings GLAFKA's representative presented the Intellectual output – infographics. Partners could see the Turkish full version. Mrs. Sevilay Sahin was satisfied with the quality and the content of the infographic video and she acknowledge she like it very much. She only mentioned that there should be done some minor corrections to Turkish version (phone number and right symbol of medical services). She confirmed her team will deliver correct phone number and graphics to GLAFKA as soon as they arrive to Gaziantep. Also all partner confirmed they are satisfied with the final product. They only recommended to change the gender of the person on welcome page – instead of male they proposed to use female figure. Lukas also talked individually to each partner to clarify their national versions. There was presented the updated template to be completed by partners with their national data (in order to finalize individual videos for

each country). There was given new deadline to partners to deliver the final data for the national version of infographics (1st June 2018). Partners were asked to deliver their contribution by agreed date so GLAFKA is able to produce videos before the LLT to be held in Gaziantep, Turkey. It was agreed that once all videos are finalized will be uploaded to the cloud and each partner will have access to those files.

Guest

Vendula Švecová, the representative of the institution Nesehnuti was invited to talk about the current immigration and refugee situation in the Czech Republic. She introduced the most important facts. Partners could ask questions.

Management

It was agreed that all partners documents will be uploaded to the project Google drive. There was clarified the user name and password.

LTT

Turkish team presented the draft programme of the LTT activity. Partners shared their proposals and recommendations. It was highlighted by partners that this activity is a training not a partner meeting therefore no management and administration matters will be discussed during the LTT. It will be mainly focused on best practices, results, knowledge transfer and sharing ideas. All representatives shall be ready to present themselves as well the current situation in their country. Some partners expressed their fear because of current situation in the area. Turkish team ensured that Gaziantep is safe location. It was recommended to arrange the commercial health insurance for participants. Partners asked the host organization about the accommodation arrangement. The host partner promised to provide list of hotels with prices as well to send all partners the Info pack with practical information for participants (hotels, way from/to airport, ...)
