## **Transnational Meeting Minutes**

## 22.01.-25.01. 2018, București/România

### 1. First day of study visit:

Participants from all partner states have arrived in Bucharest on 22<sup>nd</sup> January 2018. On the 23<sup>rd</sup> January we met with all partners at the meeting venue in Marshal Garden Hotel alongside representatives from the General Inspectorate of Immigration and some of the local NGOs active in providing services to refugees – Save the Children Romania, ICAR Foundation and ARPS Foundation.

The study visit started with a presentation of the hosting Partner's (ARCA – FRRM) Activities and services for refugees for the past 3 years – lobby, advocacy, integration, socio-legal counseling, cultural accommodation, language training, skills training, employment assistance, and direct assistance.

The presentation was followed by the presentation of the responsibilities and activity of the General Inspectorate for Immigration – Ministry of Internal Affairs, asylum administrative and legal procedure, integration program and services as well as assistance and benefits provided by the Romanian state.

The ICAR Foundation presented their activity with free socio-medical assistance and psychological therapeutical services. Their services have been addressed to all categories of beneficiaries and starting with 2002 they have included asylum seekers and refugees on their list. ICAR also presented a compendium of tools that could be of use to partners present in the study visit.

ARPS Foundation is coordinating the advocacy efforts of partner NGOs on migration and asylum issues. They have been the lead in research on migration flows, demographics and tool development for refugee assistance and integration.

### 2. Booklet

We discussed upon each partner's booklet draft and all partners decided to send all the booklet drafts to the coordinating Turkish partner for checking and approval. If the Turkish coordinator gives approval all booklets will go to Albania for formatting intro final form.

22-23.05.2018 - Tirana, Albania


11-15.06.2018 – Gaziantep, Turkey (practical training) – The coordination will give us the specifics
